

#### SMT DAMYANTIBEN PRAVINCHANDRA SHAH (ZAT) TREATMENT FOR ORTHOPADIC SURGERY

Every year our subcommittee caters to the needs of members of our society to meet their hospital bills and medical expenses. Our sub committee headed by the convener of Shri Samir Jayendra Gandhi this year provided relief to 7 families with a total sum of Rs 144400/- towards Hospital subsidy and Rs 30072/- towards reimbursement of medical expenses during the year.

#### SHREEJI MEDICLAIM YOJNA

Mediclaim is one type of assurance by the insurance company to reimburse the amount spent by an individual towards getting medical treatment if hospitalized up to the extent of amount insured as per the policy. Our aim has been to extend the benefits of this scheme to the maximum members in order to safe guard against the unwanted medical calamity.

Under this scheme we reimburse 50% of the premium amount paid. However in some deserving cases 90% of premium has also been reimbursed.

Our subcommittee headed by the convener Shri Kirtibhai Hiralal Kadakia enrolled 153 members from 53 families. Agaist the budget total amount reimbursed was Rs 258562/- as against the total premium of Rs484681/-

Sangh purchases the note books directly from the manufacturers & students are given the benefit of buying these note books at a concessional rate (lesser than the market rate). Jumbo size note books were sold at the rate of Rs150/- per doz. with a total expense incurred of Rs 55356/- Various distribution centres were set up viz for (Colaba to Bandra) at Shree Balasinor Navyuvak Sangh office , (Khar to Andheri) at Residence of Shri Himanshu Harishchandra Desai, From Jogeshwari to Kandivali at Residence of Smt Kokilaben Hiralal Parikh (Dabli), from Borivali to Virar at Residence Shri Hemendra Ramanlal Shah (Chakwa) for the comfort of its members. Sangh is thankful to all of them & their families for allowing us to carry out the activity at their places.




